(REGARDING THE APPLICATIONS TO BE MADE BY THE PERSONAL DATA SUBJECT TO THE DATA CONTROLLER)

GENERAL EXPLANATIONS

Personal data holders defined as data subjects (“Data Subject”) in the Law no. 6698 on Protection of Personal Data (“Law”) are granted certain rights regarding processing of personal data in Article 11 of the Law.

In accordance with the first paragraph of Article 13; applications to be made regarding these rights must be communicated with Deutsche Bank A.Ş. (“Data Controller” or “Bank”) in writing or via other methods determined by the Board on Protection of Personal Data (“Board”). In this respect, applications to be made to the Bank must be communicated to our side “in writing” by using this form to be delivered to us via

- registered letter with return receipt or
- personal delivery at the address below.

Please find below information on how written applications will be delivered to our side:

at the address of *Esentepe Mahallesi, Büyükdere Caddesi, Tekfen Tower No: 209 K: 17-18 Şişli 34394 Istanbul, Turkey*, by indicating that the applicant is making a **Deutsche Bank Data Subject Application**.

The above mentioned channels are “written” application channels, as stipulated in the first paragraph of Article 13 of the Law. After the other methods to be determined by the Board are specified, the Bank will separately announce how these other methods will be used by the Bank to receive the applications.

The applications delivered to our side will be replied “as soon as possible and, in any way within not later than thirty days” as of the date the application was received by our side and based on the characteristics of the request free of charge in accordance with the second paragraph of Article 13 of the Law. However, if the requested transaction requires an additional cost, please be advised that you will be asked to pay the fee in the fee tariff specified by the Board on Protection of Personal Data. Bank’s replies to the applications will be delivered in writing or via electronic media in accordance with Article 13 of the Law.

Information and documents to be requested of you based on this form and characteristics of your request should be provided to our side fully and accurately. In case the information and documents requested cannot be duly provided, the Bank may face difficulties in conducting the necessary research that should be conducted to reply your request. In this case, Bank’s legal rights will be reserved. For this reason, please be kind to return this form with the information and documents requested attached fully and accurately.
